REVISED CIRCULAR

Subject: Process for Provision of Govt. Quota Bed for Already Admitted Patients (CPT 4) and Pvt. Preference Logged Cases (CPT 6)

The circular No. Spcl/Com/PR/1379/2020-21 stands withdrawn with immediate effect and the following guidelines & protocol shall prevail in cases where ZCCCs raise requests for provision of government bed facility for CPT 4 (Already Admitted cases) and CPT 6 (private admission preference cases)

• **A. Process flow for provision of government bed for CPT 4 (Already Admitted cases):**

1. If the patient is already admitted in a Govt. Facility i.e. Govt Hospital or Govt Medical College, then the ZCCC can propose
 - i. Bed blocking in the same Govt facility
 - ii. Bed blocking in a higher Govt facility, if higher medical care is recommended
2. If the patient is already admitted in a private hospital, under the following two scenarios, then action as mentioned below can be taken:
 - a. *Admitted for non-covid treatment* – in a non-covid hospital and tested positive under investigation: Zones can shift the case to CPT 1, and provide bed blocking accordingly in a Government Facility.
 - b. *Admitted for non-covid treatment* – in a covid hospital and tested positive under investigation,
 - i. If patient needs specialized care and/or is admitted as an emergency in ICU-V bed, seek a letter from the respective hospital/treating physician detailing the clinical condition and depending on the justification provided, following action may be taken: Zonal or Taluk Health Officer shall place an official request for ICU/ICU-V bed in that hospital in the prescribed format (Annexure 1) with necessary documents enclosed with it to the Chief Health Officer, BBMP via email at choph515@gmail.com or by hand, with copy to CPT Cell, BBMP at cptcellbbmp@gmail.com. The CHO(PH) shall be the

responsible officer for approval of such cases, based on the justification provided by the zones.

B. Process flow for provision of government bed for CPT 6 (Private Admission Preference cases)

1. If the patient is seeking treatment under Government quota, then ZCCCs can proceed to block a bed in a Government Facility and shift the patient accordingly.
