CIRCULAR

Subject: Process for Provision of Govt. Quota Bed for Already Admitted Patients (CPT 4) and Pvt. Preference Logged Cases (CPT 6)

Preamble:

Covid 19 has been declared as a pandemic by the World Health Organization (WHO). Since the identification of first Covid 19 case in March 2020, Bruhat Bengaluru Mahanagara Palike (BBMP) has been fighting on war footing basis.

BBMP has set up zonal covid command and control centres (ZCCCs) at each of its eight zones, and four taluks from Bengaluru Urban to effectively manage early identification, shifting, testing, tracing, and tracking of Covid cases.

ZCCCs are equipped with technologies to handle patient shifting. Index Application 2.0 (IA 2.0) and Centralized Hospital Bed Management System (CHBMS) are among the key technological platforms available.

ZCCCs receive the line list of Covid 19 cases belonging to Bengaluru Urban district on IA 2.0. Cases are divided into different categories or buckets (as listed below), based on Call for Care (CFC) - Aapthamitra inputs.

- CPT 1 Hospital Admission
- CPT 2 CCC Admission
- CPT 3 Home Isolation
- CPT 4 Already Admitted
- CPT 5 Pvt Admission with Govt Transport
- CPT 6 Pvt Admission preference
- CPT 7 Untraceable

As per protocol defined by Covid Patient Shifting Taskforce (CPST), Govt. Quota beds can be allocated in the normal courses for all cases as per triaging outcome, except for those cases in CPT 4, 5 & 6 categories.

However, of late, Covid Patient Tracking (CPT) Cell at BBMP HO has noticed many requests from ZCCCs to allocate a government bed for deserving cases under CPT 4 and CPT 6.

With a view to provide access to Government beds in deserving cases the following circular directions shall be followed by all zones:

As detailed above, the following protocol shall have to be followed by zones raising requests for provision of government bed for CPT 4 and CPT 6 category patients.

- 1. Process flow for provision of government bed for CPT 4 (Already Admitted) cases:
 - Only the cases admitted within the 24 hours of raising the first request or getting the BU number or logging as CPT 4, whichever is earlier, shall be considered to place a request with CPT Cell, BBMP H.O.
 - 2. If the patient is admitted in a Govt. Hospital
 - i. Zones can propose bed blocking in the same hospital
 - ii. If seeking shifting to a different facility, zones can transfer the request to 108 Ambulance Service to triage and facilitate accordingly. (This shall be considered only for HDU/ICU)
 - 3. If the patient is admitted in a private hospital
 - a Admitted for non-covid treatment in a non-covid hospital and tested positive under investigation: Zones to shift the case to CPT 1, and provide bed blocking accordingly
 - b. Admitted for non-covid treatment in a covid hospital and tested positive under investigation:
 - i. If patient needs specialty care such as dialysis, cardiac, pregnancy etc. and/or admitted as an emergency to HDU/ICU/ICU-V, seek a letter from the respective hospital/treating physician detailing the clinical condition and if fit/unfit to be transferred to a different facility. *If fit*, transfer the case to 108 for shifting to a suitable Govt. Facility. *If Unfit*, Zonal or Taluk Health Officer shall place an official request in the prescribed format (Annexure 3) with necessary documents enclosed with it to the Chief Health Officer, BBMP via email or by hand. Decision shall be taken on case-to-case basis, if need be with further approval from Special Commissioner (SWM).
 - c. Admitted for Covid treatment:
 - i. Same as 3b (i)
- 4. In all CPT 4 cases where either the patient or patient party denies the offered bed in a Govt. Facility or as per the suggestion of zonal/108 triage team, they shall be advised to continue in the current facility as a private patient or call 108 in case of further assistance in case of emergency.

2. Process flow for provision of government bed for CPT 6 (Private Admission Preference) cases:

If the patient is seeking/agreeing for admission in a Govt. hospital/medical college, ZCCCs
 If the patient is seeking/agreeing for admission in a Govt. hospital/medical college, ZCCCs

2. If the patient is seeking a bed in a private hospital:

- a. If needs specialty care such as dialysis, cardiac, pregnancy seek a letter from the respective hospital/treating physician detailing the clinical condition and/or the patient/patient partly shall submit necessary medical documents to support. *If justification is not-convincing enough*, transfer the case to 108 for shifting to a suitable Govt. facility. *If justification is convincing*, Zonal or Taluk Health Officer shall place an official request in the prescribed format (Annexure 3) with necessary documents enclosed with it to the Chief Health Officer, BBMP via email or by hand. Decision shall be taken on case-to-case basis, if need be with further approval from Special Commissioner (SWM).
- 3. In all CPT 6 cases where either the patient or patient party denies the offered bed in a Govt. Facility or as per the suggestion of zonal/108 triage team, they shall be advised to continue as a private patient or call 108 in case of further assistance in case emergency.






