ORDER

Subject: Refixation of rates for RT-PCR testing and Rapid Antigen Testing.

Reference: (1) Circular No. HFW 74 ACS 2020, dated 31.3.2020

- (2) Circular No. HFW 89 CGM 2020, dated 17.4.2020
- (3) Order No. HFW 264 ACS 2020, dated 24.07.2020.
- (4) Order No. HFW 307 ACS 2020, dated 17.08.2020.

Vide Circular at reference (1) above, the maximum cost of COVID-19 testing fixed by the ICMR using RT-PCR technique vide Order F.No.Z.28015/23/2020-EMR, dated 21.3.2020 was re-circulated. Vide Circular at reference (2) above, the total testing cost of Rs.2,250/per sample was fixed by the State Government including the screening test and confirmatory test, for the samples referred by the State Government. Vide Order No. HFW 264 ACS 2020, dated 24.7.2020, the Rate of RT-PCR testing for the samples sent by Government in private laboratories was fixed to Rs.2,000/- per test and Ceiling rate for private samples in private laboratories was fixed to Rs.3,000/- per test. Vide Order No. HFW 307 ACS 2020, dated 17.08.2020, the Rate of RT-PCR testing for the samples sent by Government in private laboratories was fixed to Rs.1,500/- per test and Ceiling rate for private samples in private laboratories was fixed to Rs.2,500/- per test inclusive of cost of PPE Kit. As the rates of RT-PCR reagents have come down, the Task Force Committee has now reconsidered the issue of re-fixation of rates for RT-PCR to be charged by the private laboratories and has ordered to re-fix the rate of COVID-19 testing as follows:

- (i) Rate of RT-PCR testing for the samples sent by Government in private laboratories including screening test and confirmatory test Rs.1,200/- per test inclusive of the cost of PPE kit.
- (ii) Ceiling rate for private samples in private laboratories including screening test and confirmatory test Rs.1,600/- per test inclusive of the cost of PPE kit.

Testing can be done only in the ICMR approved laboratories and all other conditions laid down by the ICMR and the State Government shall apply.
