### SOP for Reporting of COVID-19 test: (Updated on 18.08.2020)

1. The testing lab should ensure the following before acknowledging the sample receipts:
  - a. SRF ID is generated using RT-PCR app for every sample. Sample should not be processed if submitted without SRF ID
  - b. Hard Copy: An abstract of SRF IDs with categorization details of all samples being submitted should be sent along with the samples in the format annexed. (Annexure-1). Soft copy of the same should be mailed to the RT-PCR testing laboratory.
2. As the District Surveillance Officers of all the districts are given access to ICMR portal to view the results directly, the testing lab should mandatorily upload the results in the ICMR portal **immediately** after the test.
3. If the test is "POSITIVE", the test results of admitted patients may be communicated to the treating doctor for needful action.
4. The results of the cases for which the SRF details could not be uploaded on ICMR Portal should be reported immediately through e-mail to District Surveillance Officer with a CC to [knlabcovid19@gmail.com](mailto:knlabcovid19@gmail.com). The e-mail IDs of DSOs and DHOs are annexed. (Annexure-02).
5. Lab should send SMS to the patients with COVID-19 NEGATIVE results in the given format. (Annexure-03).
6. All laboratories should compulsorily be registered under RT-PCR App. Contact the District Surveillance Officer for registration.

#### SOP for Rapid Antigen test reports:

1. All samples should mandatorily be collected through RT-PCR App to generate SRF ID.
2. If the RT-PCR lab is doing Rapid Ag test, the results should be uploaded to ICMR portal using the same login credentials that are used for uploading results of RT-PCR tests.

3. Only ICMR approved Rapid Ag kits should be used for testing. Visit <https://www.icmr.gov.in/ckitevaluation.html> for details of approved antigen kits.
4. If the test is "Antigen POSITIVE", individual should be considered 'Confirmed Positive'.
5. If the test is Negative, and suspect is Asymptomatic, individual should be considered as 'confirmed negative'.
6. If the suspect is 'symptomatic', another NP/OP swab is collected (**without generating new SRF ID**) in VTM for real-time RT-PCR test. Follow the ICMR algorithm attached below.
7. If the suspect is 'Symptomatic', the Samples should be collected for both Rapid antigen test and RT-PCR test together at a time from all Symptomatic cases irrespective of Antigen test result. If the Antigen test result turns out,
  - a. POSITIVE, then the sample collected in the VTM may be discarded in biohazard bag (double layered, leak proof) containing 2% Lysol or 5% freshly prepared hypochlorite solution. The bag is then sealed using plastic tag and disposed in accordance with the national guidelines for biomedical waste disposal.

  - b. NEGATIVE, then the sample collected in the VTM can be sent to RT-PCR lab along with the same SRF ID for confirmation.

#### ICMR portal entry:

1. All test results should be uploaded to ICMR portal irrespective of the method of test performed.
2. If the RT-PCR lab performs rapid Antigen test, the test result should be mandatorily be entered into the ICMR portal using the same login credentials used for uploading RT-PCR results.
3. Fetching SRF of RT-PCR repeat/follow up samples:

(New SRF ID will be provided along with the repeat/ follow up samples that were tested by any method other than Rapid Antigen test)

  - c. If the first test is done in the same lab, then 'List/Edit/Follow up' option can be used to fetch the patient details for the repeat/follow up test.
  - d. If the first test is done in some other lab, then the patient details can be retrieved using 'Search Patient' option.

4. Fetching patient details for follow up sample from Symptomatic Negative cases tested using Rapid Ag kit:
- a. Ensure the availability of ICMR ID/Patient ID for each follow up samples that were tested Negative by rapid antigen test from Symptomatic cases.
  - b. Retrieve such follow up samples only through 'Search patient' option to enable linking of the Antigen test with follow up RT-PCR test.
  - c. When the SRFs of such cases are tried to retrieve in the RT-PCR lab through 'add record from SRF portal' option, an error message saying "The record corresponding to this SRF is already fetched by xyz lab" will appear as the antigen test result has already been uploaded to ICMR portal for this SRF. Hence, the RT-PCR lab should retrieve such cases through "Search Patient" option.
  - d. While entering results through Search Patient option, if an error message saying "No matching records found", then please communicate to the concerned District Surveillance Officer of the district to upload the Antigen test results.
  - e. If a blank page without any patient details opens for any SRF, please communicate to the concerned DSO to confirm if the SRF is submitted properly by the swab collector in the RT-PCR App. There may be a chance of deleting the SRF after generation due to various reasons at swab collection center.
